State By-laws chair Donna Gratts presented an amendment to the Appendix of the state Bylaws. The Amendment to the Appendix was approved at Spring Board and will be voted upon at BPW/Kansas State Convention on June 2, 2018 as an item of business during the General Session. If passed the increase becomes effective July 1, 2018.

Current Appendix: Dues Structure Per Active Member Total Amount (not to include local) to BPW/Kansas \$40.00 (Distributed as follows: State Federation \$37.00 and State Foundation \$3.00, Per Student Member Total Amount (not including local) State Federation \$22.00 and State Foundation \$2.00, and Per Youth Affiliate Total Amount (not including local) State Federation \$8.00.

Change to Appendix: Dues Structure Per Active Member Total Amount (not to include Local) to BPW/Kansas \$60.00 (Distributed as follows: State Federation \$57.00 and State Foundation \$3. Per Student Member \$30.00 Total Amount (not including local) State Federation \$28.00 and State Foundation \$2.00 and Youth Affiliate Total Amount (not including local) State Federation \$12

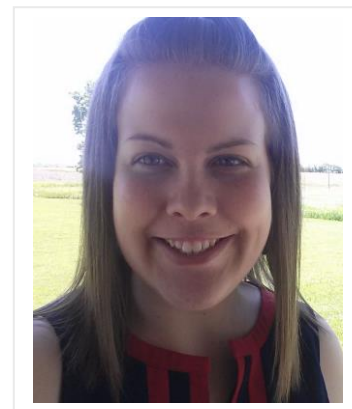

BPW/KANSAS RULES FOR CANDIDATES

=====

Nominations for office will be accepted from the floor at state convention for the officer of President-Elect, Vice President, Secretary, and Treasurer. Credentials should be given to nominations Chair, Jeanna Fancella for review prior to the start of state convention,

Guidelines for the candidates for a BPW/Kansas Office (President-Elect, Vice President, Recording Secretary, and Treasurer) are as follows:

1. Candidates will submit to the Nominations Chair the following information:
 - A copy of the minutes of the local organization meeting at which the candidate was endorsed must be submitted
 - The candidate must write a letter agreeing to serve if elected
 - The candidate must provide a resume indicating the past BPW/Kansas and local organization activities and qualifications for the office sought.
 - The candidate must provide a black and white glossy photo or digital photo for publication.
2. Candidates who submitted the above information to the Nominations Chair by the March 1, 2018 deadline will have their names printed on the ballot.
3. Candidates who submit the above information to the Nominations Chair after March 1, 2018 will run as "write-in" candidates and their nomination will come from the floor of the state convention on Saturday, June 2, 2018.
4. Once candidates have submitted their information to the Nominations Chair, all candidates, including those to be nominated from the floor of the convention, may campaign for the office they are seeking by following the guidelines listed below:
 - May distribute one piece of campaign literature i.e., brochure or one-page informational piece at any of the following BPW/Kansas meetings: Spring Conference and State Convention and/or mail to local organizations. Mailing information (not to include labels) for L/O Presidents may be requested from President Christina Rush
 - May distribute one promotional item at a BPW/Kansas meeting (Spring Conference and/or State Convention).
 - May request from the Convention Chair, Jeanna Fancella table space, not to exceed 3 feet, to display candidate information. **Note:** all campaign material must be picked up by 10:00 a.m. on Saturday, June 2, 2018.
5. Failure to follow these guidelines may result in loss of eligibility to be considered as a candidate for office.

Candidates must be employed, an active member in good standing, and officially and publicly support the State Legislative Platform. Candidates for president-elect and vice president must have served one year as a chair or elected officer of the Kansas state board of directors.

POLICY & PROCEDURE CHANGES

=====

Changes to the BPW/Kansas Policy and Procedures were approved at the Spring Board meeting March 10, 2018 in McPherson KS. Changes made include:

SF 201 Page 2 of 3 under 4. President-elect shall: added (g) have the authority to negotiate and sign contract for hotel, motel, or meeting spaces for their upcoming year as President, with a cap of contract price of \$800.00 and follow with electronic Executive Committee email vote and approval.

SF 204 Page 2 of 2 Under C. Standing and Special Committee Chairs and Nominations Chair (Note: Committee members, taskforce members, non-voting Board members and other special appointees do not receive reimbursement.)
Remove 1. Shall receive twenty (20) cents per mile a. Business meetings when over 100 miles (round-trip) and convention Business meetings when over 50 miles (one-way).
Then 2. becomes 1. Lodging a. Business meetings (1) Fifteen (15) dollars per night, or actual cost, whichever is less for maximum of two (2) nights. Then 3. becomes 2. Miscellaneous a. Copying shall be done by the Executive Secretary unless it can be obtained at a lesser cost. b. No unbudgeted expense (anything over fifty (50) dollars) will be incurred without prior approval of the state President.

An interesting development of the evening was several people attending the program shared their own stories of having a stroke or heart attack.

We warmly invite your club and State Federation to reconnect to your BPW heritage through the National Federation of Business and Professional Women's Clubs.

We are extremely happy to announce that our organizations, the **National Federation of Business and Professional Women's Clubs – NFBPWC** and its Emblem have been officially trademarked and patented by the United States Patent and Trademark office (USPTO) on 22nd August 2017. **NFBPWC** has also been registered as a corporation. This is now our official legal name, and we will stop using Enterprising and Professional Women USA, effective immediately.

Almost 10 years after the dissolution of BPW/USA, the overwhelming response from BPW/USA affiliates across the country has been that they would like to be a National Federation again under one umbrella. This would give us more strength and visibility to continue to build on our great legacy and to reclaim our historical years of accomplishment as a National Federation. We are already a country affiliate of the International Federation of Business and Professional Women (IFBPW) established in 1930 after the NFBPWC was formed.

Future Outlook and Reasons for a Unified National Federation

- Oct 23-27, 2017 was the triennial BPW International Congress in Cairo, Egypt
- We had a huge USA delegation of 35 attending
 - The 10th annual BPW International Leaders Summit held March 9-10 prior to the United Nations 62nd Commission on

Status of Women (A benefit of international membership and open to all our members) is a unique experience to gain knowledge of all aspects of BPW International.

- ERA – Equal Rights Amendment is our top priority!
- BPW USA was at the forefront of ERA in 1972, marching and raising over \$250,000 for the ERA Campaign in 1973-74. NFBPWC is a leading partner in the ERA Coalitions and represented on their national committees. The ERA has considerable buy in now from many organizations and from all levels of civil society and business. It would be a wonderful legacy of closure for NFBPWC to finally get the ERA passed.
- NFBPWC will gain back our great legacy. Traditionally our General Assembly was held each July and so we will be having our Biennial General Assembly and Conference in Orlando, Florida 20-22 July 2018 to celebrate our federation and our 100th year anniversary.
- NFBPWC is hosting the 30th International Congress in 2020 in Orlando, Florida, it has been 34 years since an International Congress was held in the USA.

We warmly invite all our BPW sisters in the USA to reconnect with a vibrant and growing list of State Federations and clubs, in locations like California, Colorado, Florida, Illinois, New York, North Carolina, Pennsylvania and Texas. Together, we can make a difference, highlighting and building on our great and rich collective legacy that will make us all very proud of the historical accomplishments, which are ours in common.

Here's how to reconnect:

1. Any 10 members within a BPW state Federation (not yet affiliated with NFBPWC) can form a club and the club can join.
2. Then, as the state promotes and gets approvals and agreements to proceed further with 3 or more clubs (or a minimum 60 members), the State Federation joins NFBPWC.

Fees to join NFBPWC is \$45 per member annually which is literally beans, (No really- charities are always saying something costs less than a cup of coffee per day. This is only 12 cents per day, which is about the cost of 60 plain coffee beans). This incredible bargain allows you to support our work for women nationally and internationally.

The annual fees includes

- ✓ NFBPWC \$21.45
- ✓ NFBPWC Biennial conference Fund \$0.75
- ✓ IFBPW \$20
- ✓ IFBPW – North America Region \$2.25 (Canada, UA and the Caribbean)
- ✓ IFBPW International Congress Fund \$0.55
